OFFICE MEMORANDUM

Subject: Financial closure of Pradhan Mantri Kaushal Vikas Yojana (PMKVY 2.0) (2016-20) - Submission of pending committed liability alongwith Utilisation Certificates (UCs) for the release of funds under PMKVY 2.0 - reg.

Reference is invited to this Ministry's (MSDE) D.O. letter no. SCH/11/2/2021-SNP dated 27.01.2021 and OM no. of even no. dated 16.09.2021 vide which State Governments / State Skill Development Missions (SSDM) were requested to furnish the details of available unspent / unutilised funds along with the remaining committed liability for the training organised under PMKVY 2.0. Despite multiple communications through email and telephonic conversations, it is stated that aforesaid requisite information has not been received from all of the States/UTs (*list annexed*).

2. Accordingly, all the States/UTs/SSDMs are requested to share the **updated details of funds utilised (*alongwith Utilization Certificates (UCs)*) and remaining committed liability for the training under CSSM-PMKVY 2.0 to this office by 05.03.2022; failing to which no funds will be released** to those States/UTs who will not submit the requisite documents within time. Also, all the pending assessments under PMKVY 2.0, if any, shall be completed by 15.03.2022.

3. States/UTs have been bifurcated in three categories and action taken is given below:

C States/UTs those who have stated that they do not require additional funds.	Updated details shall be shared if States/UTs want to utilize the PMKVY 2.0 funds under PMKVY 3.0, a separate proposal with all the details shall be shared with the Ministry before 05.03.2022.



Now, training, assessments, certification and placements also have to be completed at the earliest so that the PMKVY 2.0 can be closed physically and financially.

3. Accordingly, all the States/UTs/SSDMs are requested to share the **updated details of funds utilised (alongwith Utilization Certificates (UCs)) and remaining committed liability for the training under PMKVY 2.0 to this office by 30.09.2021.**

4. If abovesaid requisite information/documents will not be received from States/UTs/SSDMs within stipulated time, it will be presumed that no additional fund is required by the States/SSDMs for the implementation of PMKVY 2.0.

Dear *Principal Secretary/ Secretary,*

With the support of States/UTs, Pradhan Mantri Kaushal Vikas Yojana 3.0 (PMKVY 3.0) (2020-21) was launched successfully on 15th January, 2021. As envisaged, training under both the Central and State component of the scheme has commenced from 15th Jan, 2021.

2. Under PMKVY 3.0, there is a provision of utilization of unspent/unutilized funds of PMKVY 2.0 for the implementation of PMKVY 3.0. In this regard, MSDE has also issued OM no. B-12011/01/2016-SDE (Part III) dated 01.01.2021 approving Recognition of Prior Learning (RPL) under State (CSSM) component of PMKVY 3.0 by utilizing unspent fund allocated for Short-Term Training under State component (CSSM) of PMKVY 2.0

3. Further, under PMKVY 3.0, District Skill Committees (DSCs) are the focal point of implementation of scheme. DSC shall play a major role in preparation of District level plan, mobilization and counselling of candidates, formation of training batches, monitoring of quality assurance and post training support. For all the aforesaid functions, as per guidelines, funds have been earmarked for DSCs in PMKVY 3.0.

4. In view of the above, may I request you to kindly share the following at the earliest:

- (i) Furnish the details of available unspent / unutilized funds of PMKVY 2.0, after adjusting all the remaining committed liability for the training under PMKVY 2.0, which can be utilized under PMKVY 3.0.
- (ii) States/UTs have to estimate and share separately the requirement of additional funds for the implementation of PMKVY 3.0.
- (iii) A separate bank account in the name of PMKVY 3.0 (2020-21) for all the DSCs may be opened and details of the same may please be shared for seamless flow of funds to them.

Thank you for supporting the Skill India Initiative.

Sub: - Approval on rolling over of Recognition of Prior Learning (RPL) under CSSM component of PMKVY 2016-20 to PMKVY 3.0 (2020-21) for utilizing the unspent fund generated under STT-CSSM-PMKVY 2016-20-reg.

Under the "Skill India Mission", the Ministry of Skill Development and Entrepreneurship (MSDE) has been taking various initiatives to enhance participation and involvement of various stakeholders including States/ UTs. While under the Centrally Sponsored State Managed (CSSM) component of Pradhan Mantri Kaushal Vikas Yojana (PMKVY) 2016-20, regular short-term trainings (STT) have been provisioned so far, there were increasing requests from the States/ UTs seeking permission to implement Recognition of Prior Learning (RPL) under the CSSM component by utilizing the unspent funds available with States/ UTs under CSSM component of PMKVY 2016-20.

2. In this regard, it is to inform that Competent Authority (MSDE), after duly examining, has approved the request for allowing the States/ UTs to take up Recognition of Prior Learning (RPL) from unspent funds generated after meeting all committed liabilities under the rationalized financial ceiling as per circular of even no. dated 27.05.2019 for STT under CSSM-PMKVY 2016-20. The unspent funds from PMKVY 2016-20 and corresponding RPL training target may roll over under the upcoming PMKVY 3.0 (2020-21) scheme. In this regard, it may also be noted that no additional funds will be made available to any State/ UT for this purpose. The guidelines of PMKVY 3.0 (2020-21) will be shared shortly.
